 - Description of body of work
 - Minimum of five quality digital images of works in JPG or PDF format.

TIMELINE

Submissions are accepted on an ongoing basis and the CAP Selection Committee meets regularly to review artist proposals. Selected artists will be notified within 45 days of submission, at which time exhibition schedule, contracts and opening reception details will be discussed. Exhibitions are scheduled 6-12 months in advance and selections are made based on quality and compatibility with the gallery mission.

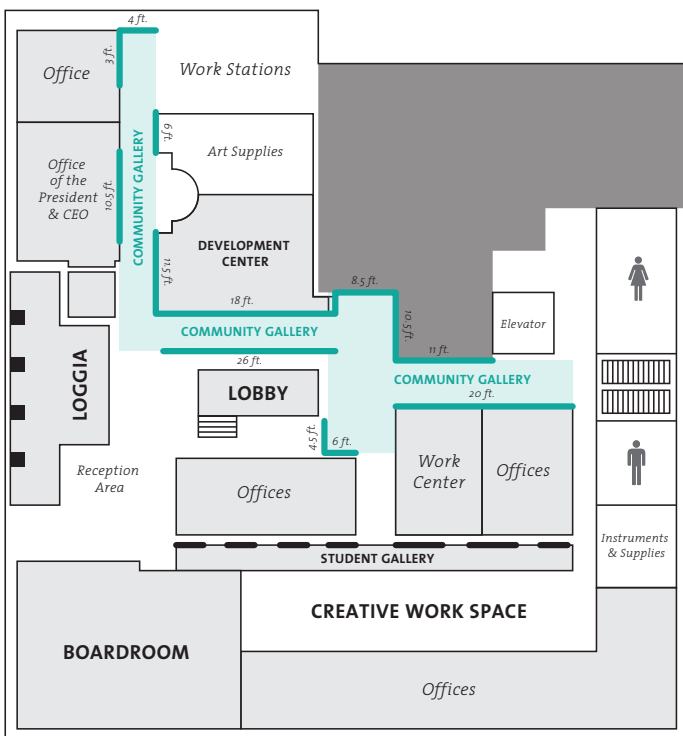
