STUDENTS EXPERIENCED MORE THAN 70 PERFORMANCE AND EXHIBITION OPPORTUNITIES THROUGHOUT THE YEAR, IMPACTING A TOTAL AUDIENCE OF 3,688. ON AVERAGE, 83% OF STUDENTS DEMONSTRATED IMPROVEMENT IN COMMUNICATING WITH ADULTS AND BEHAVING IN A COOPERATIVE MANNER WITH OTHERS IN A GROUP. 84% SHOWED IMPROVEMENT IN COMMUNICATING WITH PEERS, IN CLASS PARTICIPATION AND IN TASK COMPLETION, AND 88% DEMONSTRATED IMPROVEMENT IN PRODUCING THEIR ART FORM.
